## Introduction

When we started playing with Eucalyptus in early 2009 and with Ubuntu Enterprise Cloud a little later, we had a tough time before we could get a reasonably good grasp of the software. Eucalyptus documentation, a few white papers on the web sites of Eucalyptus Systems and Canonical Ltd., and discussions on forums were our key sources of information.

After we acquired a certain level of familiarity with the software, we felt the need for a beginner's guide of sorts to help our colleagues at CSS Corp venturing into Eucalyptus/UEC. We started writing a few wiki articles on an internal portal and when these articles were useful to some of our colleagues, we felt it would be a good idea to share the content with a wider audience. The result is this book.

## Target Audience

Our aim has been to provide a guide for a beginner to UEC. Good familiarity with virtualization is assumed, as troubleshooting many Eucalyptus-related problems requires a good knowledge of virtualization. Similarly, familiarity with Cloud Computing concepts and terminology will be of help. Prior exposure to AWS API and/or tools is not mandatory, though such exposure will accelerate the learning process greatly.

# Chapter 1

## Introduction to UEC and its components

### 1.1 Cloud

Cloud computing is a computing model, where resources such as computing power, storage, network and software are abstracted and provided as services on the internet in a remotely accessible fashion. Billing models for these services are generally similar to the ones adopted for public utilities. On-demand availability, ease of provisioning, dynamic and virtually infinite scalability are some of the key attributes of cloud computing.

An infrastructure setup using the cloud computing model is generally referred to as the “cloud”. The following are the broad categories of services available on the cloud:

- Infrastructure As A Service (IAAS)
- Platform As A Service (PAAS)
- Software As A Service (SAAS)

This cloud is generally available as a service to anyone on the internet. However, a variant called “private cloud” is increasingly becoming popular for private infrastructure that has some of the attributes of the cloud as mentioned above.

[Amazon Web Services](#) (AWS) is one of the major players providing IAAS. They have two popular services – [Elastic Compute Cloud](#) (EC2) and [Simple Storage Service](#) (S3). These services are available through web services

interfaces. The client tools can use EC2 and S3 APIs to communicate with these services. The popularity of these APIs have encouraged other cloud products to provide support for them as well.

## 1.2 Eucalyptus

[Eucalyptus](#) is a software available under GPL that helps in creating and managing a private or even a publicly accessible cloud. It provides an EC2-compatible cloud computing platform and S3-compatible cloud storage platform. Eucalyptus has become very popular and is seen as one of the key open source cloud platforms. Since Eucalyptus makes its services available through EC2/S3 compatible APIs, the client tools written for AWS can be used with Eucalyptus as well.

## 1.3 Ubuntu Enterprise Cloud (UEC)

[Ubuntu Enterprise Cloud](#), UEC for short, is a stack of applications from [Canonical](#) included with Ubuntu Server Edition. UEC includes Eucalyptus along with a number of other open source software. UEC makes it very easy to install and configure the cloud. Canonical also provides commercial technical support for UEC.

## 1.4 Components of a Eucalyptus (UEC) based Cloud

### 1.4.1 Node Controller (NC)

A UEC node is a VT enabled server capable of running [KVM](#) as the [hypervisor](#). UEC automatically installs KVM when the user chooses to install the UEC node. The VMs running on the hypervisor and controlled by UEC are called “instances”. Eucalyptus supports other hypervisors like [Xen](#) apart from KVM, but Canonical has chosen KVM as the preferred hypervisor for UEC.

Node Controller runs on each node and controls the life cycle of instances running on the node. The NC interacts with the OS and the hypervisor running on the node on one side and the Cluster Controller (CC) on the other side.

NC queries the Operating System running on the node to discover the node’s physical resources – the number of cores, the size of memory, the available disk space and also to learn about the state of VM instances running on the node and propagates this data up to the CC.

**Functions:**

- Collection of data related to the resource availability and utilization on the node and reporting the data to CC
- Instance life cycle management

### 1.4.2 Cluster Controller (CC)

CC manages one or more Node Controllers and deploys/manages instances on them. CC also manages the networking for the instances running on the Nodes under certain types of networking modes of Eucalyptus. More on this in later chapters.

CC communicates with Cloud Controller (CLC) on one side and NCs on the other side.

**Functions:**

- To receive requests from CLC to deploy instances
- To decide which NCs to use for deploying the instances on
- To control the virtual network available to the instances
- To collect information about the NCs registered with it and report it to the CLC

### 1.4.3 Walrus Storage Controller (WS3)

WS3 provides a persistent simple storage service using REST and SOAP APIs compatible with S3 APIs.

**Functions:**

- Storing the machine images
- Storing snapshots
- Storing and serving files using S3 API

WS3 should be considered as a simple file storage system.

### 1.4.4 Storage Controller (SC)

SC provides persistent block storage for use by the instances. This is similar to the [Elastic Block Storage \(EBS\)](#) service from AWS.

**Functions:**

- Creation of persistent EBS devices
- Providing the block storage over AoE or iSCSI protocol to the instances
- Allowing creation of snapshots of volumes

### 1.4.5 Cloud Controller (CLC)

The Cloud Controller (CLC) is the front end to the entire cloud infrastructure. CLC provides an EC2/S3 compliant web services interface to the client tools on one side and interacts with the rest of the components of the Eucalyptus infrastructure on the other side. CLC also provides a web interface to users for managing certain aspects of the UEC infrastructure.

**Functions:**

- Monitor the availability of resources on various components of the cloud infrastructure, including hypervisor nodes that are used to actually provision the instances and the cluster controllers that manage the hypervisor nodes
- Resource arbitration – Deciding which clusters will be used for provisioning the instances
- Monitoring the running instances

In short, CLC has a comprehensive knowledge of the availability and usage of resources in the cloud and the state of the cloud.

## 1.5 Architecture

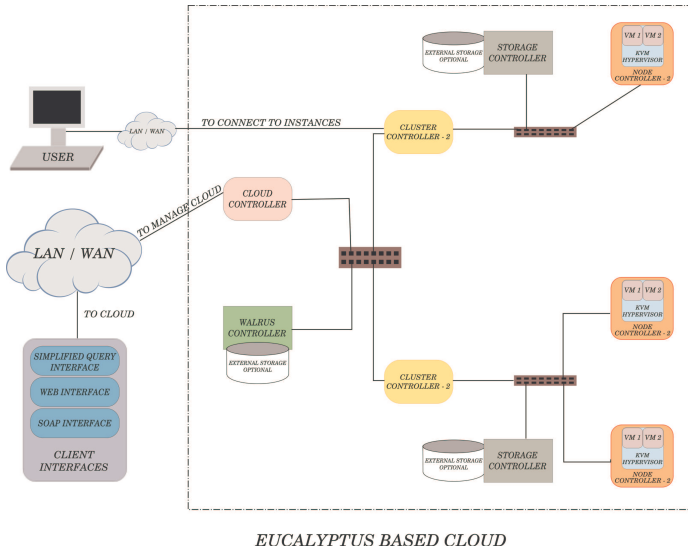


Figure 1.1: Components of UEC



# Chapter 2

## Installation & Configuration

The following sections describe how to install and configure a basic UEC setup spanning three servers. Two Servers (Server1 and Server2) will run a Lucid 64-bit server version and the third server will run a Lucid Desktop 64-bit version (Client1). We have decided on installing the Desktop version on Client1 so that we can use Firefox or other browsers to access the web interface of UEC and also to use RDP/VNC clients during the image creation process.

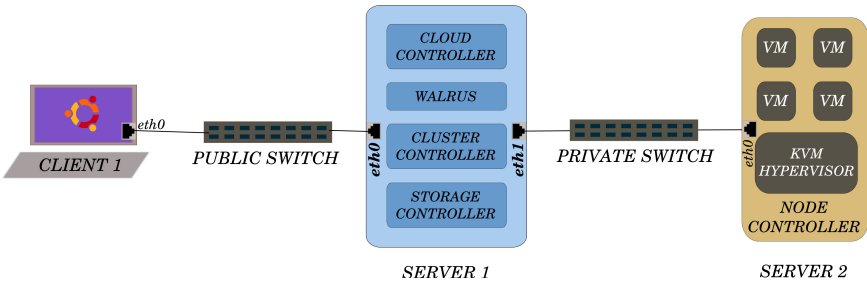


Figure 2.1: UEC basic setup with three machines

What we have used as a sample setup is a typical minimal Eucalyptus setup. Client1 above need not be a dedicated machine. If you need to setup Eucalyptus on a single server, you can refer to [UEC: CC and NC on a single machine](#) . However, such a setup will not support Managed and Managed-NOVLAN modes of networking.

Note: UEC installation is very similar to the installation of Ubuntu server, the only difference is the additional configuration screens for the UEC components. The following instructions only cover the UEC-specific options as it is assumed that you are familiar with the installation of Ubuntu server.

For ease of understanding, the instructions here in this chapter and the rest of the book assume the following sample setup. Please make necessary modifications to suit your setup.

- The gateway for Server2 is set to the IP of the CC – IP 192.168.20.1. This will enable the Server2 to connect to the enterprise network through Server1 (CC).
- Server1 is a 64-bit server and Server2 is a 64-bit VT-enabled server.
- The enterprise network runs on a class “C” private network – 192.168.10.0/255.255.255.0
- IP addresses allocated for the cloud instances as public IP addresses: 192.168.10.200-192.168.10.220 (Enterprise range)
- The UEC components will use a dedicated class “C” private network for their interconnections – 192.168.20.0/255.255.255.0
- Cluster Name – “myuecluster”

## 2.1 Server1

### 2.1.1 Installation

- Boot the server off the Ubuntu Server 10.04 CD. At the graphical boot menu, select “Install Ubuntu Enterprise Cloud” and proceed with the basic installation steps.
- Installation only lets you set up the IP address details for one interface. Please do that for eth0.
- You will need to choose certain configuration options for your UEC, during the course of the install:
- Cloud Controller Address – Leave this blank as Server1 is the Cloud Controller in this setup.
- Cloud Installation Mode – Select “Cloud controller”, “Walrus storage service”, “Cluster controller” and “Storage controller”.
- Network interface for communication with nodes – eth1
- Eucalyptus cluster name – myuecluster
- Eucalyptus IP range – 192.168.10.200-192.168.10.220

### 2.1.2 Post Install Steps & Configuration

- Set up static IP for the second network interface eth1 by adding the following to /etc/network/interfaces:

```
auto eth1
iface eth1 inet static
address 192.168.20.1
netmask 255.255.255.0
network 192.168.20.0
broadcast 192.168.20.255
```

- After making the above changes, run the following command to restart the networking:

```
uecadmin@server1:~$sudo /etc/init.d/networking restart
```

- Make sure that you have the latest version of Eucalyptus:

```
uecadmin@server1:~$sudo apt-get update
uecadmin@server1:~$sudo apt-get upgrade eucalyptus
```

- Install the NTP package. This machine is going to act as an NTP server for the nodes. The time on all components of UEC will have to be in sync. Since CLC is connected to internet, we can run NTP server on it and have other components sync to it:

```
uecadmin@server1:~$sudo apt-get install ntp
```

- Open the file `/etc/ntp.conf` and add the following two lines to make sure the server serves time even when its connectivity to the internet is down. The following settings makes sure that the NTP server uses its own clock as the clock source:

```
server 127.127.1.0
fudge 127.127.1.0 stratum 10
```

- Restart NTP service to make the changes effective:

```
uecadmin@server1:~$sudo /etc/init.d/ntp restart
```

- Save the changes and restart CC:

```
uecadmin@server1:~$sudo restart eucalyptus--cc CLEAN=1
```

## 2.2 Server2

### 2.2.1 Installation

- Boot the server off the Ubuntu Server 10.04 CD. At the graphical boot menu, select “Install Ubuntu Enterprise Cloud” and proceed with the basic installation steps.
- Installation only lets you set up the IP address for one interface. Please do that for `eth0` by setting up the private IP – 192.168.20.2
- You will need to choose certain configuration options for your UEC, during the course of the install. You can ignore all the settings, except the following:

- Cloud Controller Address – 192.168.20.1
- Cloud Installation Mode – Select “Node Controller”
- Gateway – 192.168.20.1 (IP of the CC)

## 2.2.2 Post Install Steps & Configuration

- Add your DNS server details to `/etc/resolv.conf`:

```
nameserver 192.168.10.2
nameserver 192.168.10.3
```

- Make sure that you have the latest version of Eucalyptus:

```
uecadmin@server2:~$sudo apt-get update
uecadmin@server2:~$sudo apt-get upgrade eucalyptus
```

- Install the NTP package to synchronize with the NTP server:

```
uecadmin@server2:~$sudo apt-get install ntp
```

- Open the file `/etc/ntp.conf` and append the following line:

```
server 192.168.20.1
```

- Restart NTP service to make the changes effective:

```
uecadmin@server2:~$sudo /etc/init.d/ntp restart
```

- Open the file `/etc/eucalyptus/eucalyptus.conf` and make the following changes:

```
VNET_PUBINTERFACE="br0"
VNET_PRIVINTERFACE="br0"
VNET_BRIDGE="br0"
VNET_DHCPDAEMON="/usr/sbin/dhcpd3"
VNET_DHCPUSER="dhcpd"
VNET_MODE="MANAGED-NOVLAN"
```

- After making the above changes, run the following commands:

```
uecadmin@server2:~$sudo restart eucalyptus-nc-publication
uecadmin@server2:~$sudo restart eucalyptus-nc
```

## 2.2.3 Install CC's ssh public key to NC

- On the Node Controller, temporarily set a password for the “eucalyptus” user:

```
uecadmin@server2:~$sudo passwd eucalyptus
```

- On the Cluster Controller:

```
uecadmin@server2:~$sudo -u eucalyptus ssh-copy-id -i  
~eucalyptus/.ssh/id_rsa.pub eucalyptus@192.168.20.2
```

- You can now remove the password of the “eucalyptus” account on the Node:

```
uecadmin@server2:~$sudo passwd -d eucalyptus
```

## 2.3 Client1

The purpose of Client1 machine is to interact with the cloud setup, for bundling and registering new Eucalyptus Machine Images (EMI)

### 2.3.1 Installation

- Boot the Desktop off the Ubuntu Desktop 10.04 CD and install. The Desktop will be on the enterprise network and will obtain an IP address through DHCP.
- Install KVM to help us install images on KVM platform and bundle them:

```
uecadmin@client1:~$apt-get install qemu-kvm
```

### 2.3.2 Post Install Configuration

- Install euca2ools to be able to manage the cloud from it:

```
uecadmin@client1:~$sudo apt-get install euca2ools
```

- Login to the web interface of CLC by using the following link <https://192.168.10.121:8443>. The default username is “admin” and the default password is “admin”.
- Note that the installation of UEC installs a self signed certificate for the web server. The browser will warn you about the certificate not having been signed by a trusted certifying authority. You can authorize the browser to access the server with the self signed certificate. Instruction on how to install a valid certificate signed by a trusted certifying authority is beyond the scope of this guide.
- When you login for the first time, the web interface prompts you to change the password and provide the email ID of the admin. After completing this mandatory step, download the credentials archive from <https://192.168.10.121:8443/#credentials> and save it in the `~/euca` directory.
- Extract the credentials archive:

```
$ cd .euca
$ unzip mycreds.zip
```

- Source `euca2ools` script to make sure that the environmental variables used by `euca2ools` are set properly.
- To verify that `euca2ools` are able to communicate with the UEC, try fetching the local cluster availability details:

```
$ . ~/euca/eucarc
$ euca-describe-availability-zones verbose
```

You should see something like the following if it works properly:

```
$ euca-describe-availability-zones verbose
AVAILABILITYZONE myueccluster 192.168.10.121
AVAILABILITYZONE | - vm types free / max cpu ram disk
AVAILABILITYZONE | - m1.small 0016 / 0016 1 128 2
AVAILABILITYZONE | - c1.medium 0014 / 0014 1 256 5
AVAILABILITYZONE | - m1.large 0007 / 0007 2 512 10
AVAILABILITYZONE | - m1.xlarge 0003 / 0003 2 1024 20
AVAILABILITYZONE | - c1.xlarge 0001 / 0001 4 2048 20
```

- If you see the free/max VCPUs as 0 in the above list, it means the node did not get registered automatically. Please use the following on `Server1` and approve when prompted to add `192.168.20.2` as the Node Controller:

```
uecadmin@client1:~$sudo euca_conf --discover--nodes
```



# Chapter 3

## Web interface

Ubuntu Enterprise Cloud provides a minimal web interface to manage user credentials, manage images, administer user accounts, etc.

In our sample setup, the web interface is accessible at:

```
https://192.168.10.121:8443/
```

You have already finished setting up the password for the admin user of the web interface while working on Desktop1 in the chapter “Installation & Configuration”.

A user trying to access the interface for the first time, will need to sign up and would be able to use the interface after the account is approved by the administrator. The approval of the account by the administrator results in an email to the user.

### 3.1 Using the Web Interface

After logging into the web interface, you will see seven tabs as given below:

1. Credentials
2. Images
3. Store
4. Users
5. Configuration

6. Services
7. Extras

## 3.2 Credentials

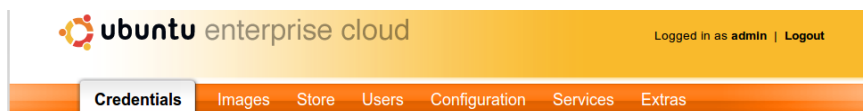


Figure 3.1: Web UI Tabs

You can change your account password, download the credentials (to be used while bringing up instances etc.) and view the query interface credentials (to be used with tools like euca2ools to query CC for information like getting the list of images, instances etc.) here. Later chapters have more detailed discussion about use of these credentials.

## 3.3 Images

You can see here a list of images that have been uploaded to the CLC. Each entry contains information about the image such as its ID, meta information like the Ids of associated kernel and ramdisk images etc. This information comes in handy when you try to bring up instances using these images. This is mostly a read-only listing, except that you can disable/enable each of the images.

## 3.4 Store

The store tab lists new images available on the UEC image store of Canonical. These are provided by Canonical and third-party providers such as M/Gateway. You can install any of these images. Installation here refers to the task of downloading and making it available for use on the local installation of UEC. After installation, the image should now show up under the Images tab along with its kernel and ramdisk images.

## 3.5 Users

As an administrator, you can create as well as view and manage user accounts here including enabling/disabling accounts and changing the passwords.

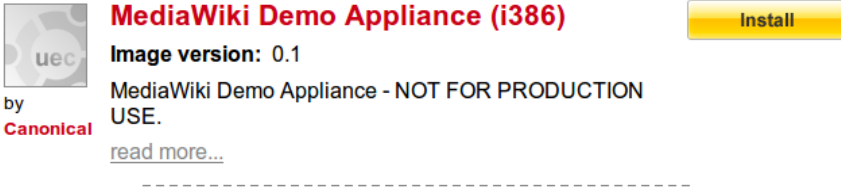


Figure 3.2: Image Store

## 3.6 Configuration

You can view and manage information related to various components of your UEC setup, such as CLC, CC, Walrus etc. You can also specify the resource limits for different VM types such as m1.small, c1.medium etc. More on this the chapter on “Instance management”

## 3.7 Services

A few pieces of commercial information about services from Canonical and their partners for UEC.

## 3.8 Extras

You can find a list of Eucalyptus-certified Images and Eucalyptus-compatible Tools like euca2ools.

# Chapter 4

## Image management

### 4.1 Eucalyptus Machine Image (EMI)

A Eucalyptus Machine Image (EMI) is a combination of a virtual disk image(s), kernel and ramdisk images as well as an xml file containing metadata about the image. These images reside on WS3 and are used as templates for creating instances on UEC. Each Linux EMI is a combination of the following:

- An XML file with a name like “jaunty.img.manifest.xml” with information about one or more hard disk images, a kernel image and a ramdisk image (id – emi-65440E7E)
- An XML file with a name like “vmlinuz-2.6.28-11-server.manifest.xml” with information about the corresponding kernel image (id – eki-39FC1244)
- An XML file with a name like “initrd.img-2.6.28-11-server.manifest.xml” with information about the corresponding ramdisk image (id – eri-71ED1322)

Each of these images has its own ID that can be used while running the instances. More on this in the chapter on “Managing Instances”

From the web interface of Eucalyptus, you can view a list of EMIs in the “Store” tab of the web UI. These are the EMIs listed from Canonical or partners. You can choose to download and install any of these images directly from Canonical’s site.

Since most enterprise/individual users of Eucalyptus have a need for bringing up instances based on custom images, image management plays a key

role in Eucalyptus administration. Such images could be based on a preferred version/variant of a preferred OS distribution with a set of required applications pre-installed.

Bundling an EMI is a multi-step process involving the following:

- creating a virtual disk image
- installing the OS
- installing required applications
- making the OS ready to run under UEC
- registering the images with UEC
- testing the image etc.

Bundling process differs between Linux and Windows images and we will discuss the process in both cases in some detail below.

## 4.2 Bundling Linux Image

We will use Client1 for the purpose of working on creation of the image. Please note that we had installed KVM on Client1.

### 4.2.1 Creating a new disk Image

This will represent the main HDD of the virtual machine, so make sure to give it as much space as you will need.

```
uecadmin@client1:~$ kvm-img create -f raw image.img 5G
```

**Note:** In UEC 10.04(Lucid Lynx), after applying the recent bugfixes, patches and updates, eucalyptus expects the disk image to be present in raw format. Hence the disk image has to be created using raw format.

### 4.2.2 OS Installation

Download the iso file of the Linux distribution you want installed in the image. The example below refers to creating a Jaunty Jackalope 64-bit server image:

```
uecadmin@client1:~$ wget
http://releases.ubuntu.com/karmic/ubuntu-9.04-server-amd64.iso
```

And start the installation process:

```
uecadmin@client1:~$ sudo kvm -m 256 -cdrom ubuntu-9.04-server-amd64.iso
-drive file=image.img,if=scsi,index=0 -boot d -net nic -net user
-nographic -vnc :0
```

If your installation process requires more than 256MB of RAM change the `-m` option, and if you need more processors available, you can use the `-c` option.

The command above will boot a new KVM instance, with the disk image you've created as the primary HDD and the iso as the first bootable device. Also the `"-nographic"` option will not display any graphical output. You can connect to the instance through VNC (use display number :0) and finish the installation. For example:

```
vncviewer A.B.C.D :0, where A.B.C.D is the IP address of the Client1.
```

After finishing the installation, relaunch the VM by executing the following command:

```
uecadmin@client1:~$ sudo kvm -m 256 -drive
file=image.img,if=scsi,index=0,boot=on -boot c -net nic -net user
-nographic -vnc :0
```

At this point you can add all the packages you want to have installed, update the installation, add users and any settings that need to be present in your new UEC instances.

```
$ sudo apt-get update
$ sudo apt-get upgrade
$ sudo apt-get install mediawiki
```

### 4.2.3 Integrating with Eucalyptus

An instance running under Eucalyptus needs to know what IP it has and also, it needs to have the public key of the user allowed to do a passwordless access through SSH. This is accomplished by using a restful interface provided by the cloud. The interface is available under this

URL: <http://169.254.169.254/latest/meta-data> and is accessible from within the instance.

Eucalyptus node controller is set up to prevent automatic key injection if the system is in MANAGED or MANAGED-NOVLAN mode. Instead, it is assumed that the instance will use the above metadata service to retrieve the public keys when running in these modes. You will need to facilitate this by installing curl and adding a script that will run on each boot.

Install curl on the VM:

```
$ sudo apt-get install curl
```

Now add the following lines to `/etc/rc.local` of the image:

```
depmod -a
modprobe acpihp
# simple attempt to get the user ssh key using the meta-data service
# assuming ?user? is the username of an account that has been created
mkdir -p /home/user/.ssh
echo >> /home/user/.ssh/authorized_keys
curl -m 10 -s
http://169.254.169.254/latest/meta-data/public-keys/0/openssh-key |
grep 'ssh-rsa' >> \
    /home/user/.ssh/authorized_keys
echo "AUTHORIZED_KEYS:"
echo "*****"
cat /home/user/.ssh/authorized_keys
echo "*****"
```

Add the above lines before the “exit 0” in `/etc/rc.local`

Also remove the network persistent rules from `/etc/udev/rules.d`, so that the instance always comes up with `eth0` as the interface name as expected by Eucalyptus:

```
$ sudo rm -rf /etc/udev/rules.d/70-persistent-net.rules
```

This completes the process of customizing the OS installed as a reference image.

#### 4.2.4 Registering with Eucalyptus

The last step is to upload the images to Eucalyptus. The files that need to be uploaded for the above sample setup are: `vmlinuz-2.6.28-11-server`, `initrd.img-2.6.28-11-server`, `image.img`.

Copy the kernel and the initrd image from the VM image to some place outside. These will be used later for creating and uploading a complete virtual image to Eucalyptus:

```
$ scp /boot/initrd.img-2.6.28-11-server user@A.B.C.D:  
$ scp /boot/vmlinuz-2.6.28-11-server user@A.B.C.D:
```

Before starting the upload process shut down the VM.

**Registering kernel image** Execute the following commands to bundle and register the kernel image (vmlinuz-2.6.28-11-server):

```
uecadmin@client1:~$ euca-bundle-image -i vmlinuz-2.6.28-11-server  
--kernel true  
uecadmin@client1:~$ euca-upload-bundle -b mybucket -m  
/tmp/vmlinuz-2.6.28-11-server.manifest.xml  
uecadmin@client1:~$ euca-register  
mybucket/vmlinuz-2.6.28-11-server.manifest.xml
```

Save the output produced by the last command above (eki-XXXXXXXX), which will be needed while registering the disk image.

**Registering ramdisk image** Execute the following commands to bundle and register the ramdisk image (initrd.img-2.6.28-11-server):

```
uecadmin@client1:~$ euca-bundle-image -i initrd.img-2.6.28-11-server --ramdisk ↵  
true  
uecadmin@client1:~$ euca-upload-bundle -b mybucket -m  
/tmp/initrd.img-2.6.28-11-server.manifest.xml  
uecadmin@client1:~$ euca-register  
mybucket/initrd.img-2.6.28-11-server.manifest.xml
```

Save the output produced by the last command above (eri-XXXXXXXX), which will be needed while registering the disk image.

**Registering disk image** Execute the following commands to bundle and register the ramdisk image (image.img):

```
uecadmin@client1:~$ euca-bundle-image -i image.img --kernel eki-XXXXXXXX  
--ramdisk eri-XXXXXXXX  
uecadmin@client1:~$ euca-upload-bundle -b mybucket -m  
/tmp/image.img.manifest.xml  
uecadmin@client1:~$ euca-register mybucket/image.img.manifest.xml
```

Replace eki-XXXXXXXX and eri-XXXXXXXX with the exact values you have saved earlier.



### 4.2.5 Image Listing

The new images that have been uploaded can be seen by using `euca-describe-images` command. For example:

```
uecadm@client1:~$ euca-describe-images
IMAGE emi-70B70ECO mybucket/image.img.manifest.xml
  admin available public x86_64 machine
IMAGE eri-A2BE13EC
mybucket/initrd.img-2.6.28-11-server.manifest.xml admin available
  public x86_64 ramdisk
IMAGE eki-685F1306 mybucket/vmlinuz-2.6.28-11-server.manifest.xml
admin available public x86_64 kernel
```

More details on managing the instances in later chapters.

## 4.3 Bundling Windows Image

### 4.3.1 Creating new disk image

This will represent the main HDD of the virtual machine, so make sure to give it as much space as you will need.

```
uecadm@client1:~$ kvm-img create -f raw win-2k3.img 20G
```

**Note:** In UEC 10.04(Lucid Lynx), after applying the recent bugfixes, patches and updates, eucalyptus expects the disk image to be present in raw format. Hence the disk image has to be created using raw format.

### 4.3.2 OS Installation

Create an ISO image of the relevant Windows installation CD. And start the installation process:

```
uecadm@client1:~$ sudo kvm -m 1024 -cdrom Win2003ServerR2x86_cd1.iso
-drive file=win-2k3.img,if=scsi,boot=on -nographic -vnc :0
```

After finishing the installation and in case you need to install from the second CD as well, reboot the VM and launch the VM by the following command:

```
uecadm@client1:~$ sudo kvm -m 1024 -boot c -cdrom
Win2003ServerR2x86_cd2.iso -drive file=win-2k3.img,if=scsi,boot=on
-nographic -vnc :0
```

Once installation is complete, we need to create the boot disk needed for Windows 2003 server.

### 4.3.3 For Windows XP bundling

While bundling Windows XP, the OS doesn't recognize SCSI driver during installation process. The following workaround is suggested:

1. Attach the disk as IDE disk:

```
$ sudo kvm -m 1024 -cdrom winxpcd.iso -drive file=winxp.img,boot=on
-nographic -vnc :0
```

2. Finish the installation of Windows XP.
3. Now create another disk image using `kemu-img`:

```
$ qemu-img create -f raw newdisk.img 5G
```

4. Start the instance by attaching the second disk as SCSI disk.
5. After Windows XP boots, it detects and installs the driver for the SCSI disk (`sys_hi.sys`)

The remaining procedure is same as that of bundling Windows 2003 Server.

### 4.3.4 Copying the boot files

Re-launch the VM using the following command, so that we can access the first CD, in order to copy some files from it:

```
uecadmin@client1:~$ sudo kvm -m 1024 -boot c -cdrom
Win2003ServerR2x86_cd1.iso -drive file=win-2k3.img,if=scsi,boot=on
-nographic -vnc :0
```

Copy the following files to a specific location to create the boot disk, say `C:\bootfiles`

- `ntldr`
- `ntdetect.com`
- `sym_hi.sys`

Rename `sym_hi.sys` to `Ntbootdd.sys` (SCSI driver needed to boot the hard disk).

In case, `sym_hi.sys` is not present in the CD, copy it from the following location of the installation:

```
C:\WINDOWS\system32\drivers
```

Write the following lines to a new file and save it as `Boot.ini` in the same location, i.e, `C:\bootfiles`:

```
[boot loader]
timeout=30
Default= multi(0)disk(0)rdisk(0)partition(1)\Windows
[operating systems]
multi(0)disk(0)rdisk(0)partition(1)\WINDOWS="Windows Server 2003"
```

Shut down the VM and proceed for the boot disk creation.

### 4.3.5 Boot disk creation

Execute the following command to create the boot disk:

```
uecadmin@client1:~$ dd bs=512 count=2880 if=/dev/zero of=win-boot.img
```

Now attach this disk as a floppy disk and start the Windows VM:

```
uecadmin@client1:~$ sudo kvm -m 1024 -boot c -drive
file=win-2k3.img,if=scsi,boot=on,index=1 -fda win-boot.img -nographic
-vnc :0
```

On the Windows VM, format the floppy disk and copy all the files from `C:\bootfiles` to the floppy. Shutdown the VM and test the boot disk created with the following command:

```
uecadmin@client1:~$ sudo kvm -m 1024 -boot a -drive
file=win-2k3.img,if=scsi,boot=on,index=1 -fda win-boot.img -nographic
-vnc :0
```

This should boot you into Windows, if you have created the boot floppy right.

### 4.3.6 Network Configuration

Now you need to download the e1000 drivers, since e1000 is the default interface that is supported by Eucalyptus. You can download the drivers from the following location:

[http://downloadcenter.intel.com/Detail\\_Desc.aspx?agr=Y&DwnldId=8659&lang=ENG](http://downloadcenter.intel.com/Detail_Desc.aspx?agr=Y&DwnldId=8659&lang=ENG)

```
For 32-bit VM, download PRO2KXP.exe
For 64-bit VM, download PROEM64T .ex
```

Once the download is finished, shutdown the VM and restart the VM with the following command:

```
uecadmin@client1:~$ sudo kvm -m 1024 -boot a -drive
file=win-2k3.img,if=scsi,boot=on,index=1 -fda win-boot.img -net
nic,model=e1000 -net tap -nographic -vnc :0
```

The above command tells the VM to make use of e1000 model as its NIC. After executing the above command, you will get this warning:

```
Warning: vlan 0 is not connected to host network
```

You can safely ignore this warning message.

After the VM boots, install the network drivers.

Enable remote desktop for all users on the VM. This is very important. This is the only way, without installing a third party tool, you can allow access to a Windows instance running on UEC. You can enable remote desktop by navigating to Start → Settings → Control Panel → System → Remote and selecting Remote Desktop option for all users. This completes the Windows disk setup. Shut down the VM.

### 4.3.7 Memdisk

The kernel memdisk is needed to load Windows. The default syslinux memdisk can be used for this purpose. If you cannot locate memdisk on CC, you need to install syslinux:

```
uecadmin@client1:~$ sudo apt-get install syslinux
```

After installing, memdisk will be found in `/usr/lib/syslinux`:

```
uecadmin@client1:~$ cd /usr/lib/syslinux
uecadmin@client1:/usr/lib/syslinux$ ls -l memdisk
-rw-r--r-- 1 root root 20068 2008-07-15 20:25 memdisk
```

Copy it to the location where you have all the Windows files.

### 4.3.8 Registering with Eucalyptus

The last step is to upload the images to UEC. The files that need to be uploaded are:

- memdisk
- win-boot.img
- win-2k3.img

**Registering memdisk** Execute the following commands to bundle and register the memdisk:

```
uecadmin@client1:~$ euca-bundle-image -i memdisk --kernel true
uecadmin@client1:~$ euca-upload-bundle -b win2k3_bucket -m
/tmp/memdisk.manifest.xml
uecadmin@client1:~$ euca-register win2k3_bucket/memdisk.manifest.xml
```

Save the output produced by the last command above (eki-XXXXXXXX), which will be needed while registering the disk image.

**Registering boot disk** Execute the following commands to bundle and register the boot disk (win-boot.img):

```
uecadmin@client1:~$ euca-bundle-image -i win-boot.img --ramdisk true
uecadmin@client1:~$ euca-upload-bundle -b win2k3_bucket -m
/tmp/win-boot.img.manifest.xml
uecadmin@client1:~$ euca-register
win2k3_bucket/win-boot.img.manifest.xml
```

Save the output produced by the last command above (eri-XXXXXXXX), which will be needed while registering the disk image.

**Registering disk image** Execute the following commands to bundle and register the disk image (win-2k3.img):

```
uecadm@client1:~$ euca-bundle-image -i win-2k3.img --kernel
eki-XXXXXXXX --ramdisk eri-XXXXXXXX
uecadm@client1:~$ euca-upload-bundle -b win2k3_bucket -m
/tmp/win-2k3.img.manifest.xml
uecadm@client1:~$ euca-register win2k3_bucket/win-2k3.img.manifest.xml
```

Replace eki-XXXXXXXX and eri-XXXXXXXX with the exact values noted down earlier.

### 4.3.9 Image Listing

The new images that have been uploaded can be seen by using euca-describe-images command. For example:

```
uecadm@client1:~$ euca-describe-images
IMAGE emi-55470DE2 win-2k3/win-2k3.img.manifest.xml admin
available public x86_64 machine
IMAGE eki-2BC30D1B win-2k3/memdisk.manifest.xml admin
available public x86_64 kernel
IMAGE eri-76C20ED5 win-2k3/win-boot.img.manifest.xml admin
available public x86_64 ramdisk
```

### 4.3.10 Running instance of custom image

To launch a new instance of the custom image, execute euca-run-instances command:

```
uecadm@client1:~$ cd .euca
uecadm@client1:~/.euca$ euca-run-instances emi-55470DE2 -k mykey -t
c1.xlarge
```

Since this is a Windows instance the VM type is specified as c1.xlarge, which has 20GB of hard disk space.

The above procedure for bundling Windows images worked on Ubuntu 9.10 (Karmic Koala). But it fails on Ubuntu 10.04 (Lucid Lynx). Please refer to [Chapter 11](#) for a hack to get Windows images running on Lucid Lynx.

# Chapter 5

## Instance management

There are broadly three types of tools that you can use to manage Eucalyptus instances.

- Firefox Plugins – Elasticfox and Hybridfox
- Command Line tools like euca2ools
- Custom applications developed using EC2 APIs. (Will not be covered in this beginner's guide)

### 5.1 Elasticfox

Elasticfox is an open source Mozilla Firefox extension that works on Firefox Version 2.0 or later to help you with managing your Amazon EC2 account: Launch new instances, mount Elastic Block Storage volumes, map Elastic IP addresses, and more. This was originally written for EC2, but, since version 1.7, Elasticfox added Eucalyptus support as well, because API of Eucalyptus is compatible with that of EC2.

#### 5.1.1 Features

- List available Machine images (AMIs in the case of AWS and EMIs in the case of Eucalyptus)
- List running instances
- Launch new instances of an AMI/EMI
- Manage security groups and rules
- Manage Snapshots/EBS volumes

## 5.1.2 Installation on Firefox

Install the extension from <http://s3.amazonaws.com/ec2-downloads/elasticfox.xpi>

You will need to restart Firefox before you can start using Elasticfox. You can launch Elasticfox from “Tools” menu of Firefox.

## 5.1.3 Configuration

### Define a Region

- Click on Regions button
- Enter a logical name for the region (Example: “Eucalyptus” , “MyEucalyptus” etc.)
- Enter the value of EC2\_URL from your eucarc file as the Endpoint URL (<http://192.168.10.121:8773/services/Eucalyptus> in our sample setup)

### Define Credentials

- Click on Credentials button
- Enter a logical name for the credential set (Example: “EucaAcc1 etc.)
- Enter EC2\_ACCESS\_KEY and EC2\_SECRET\_KEY from your eucarc file as the AWS Access Key and AWS Secret Access Key respectively

### Define Key Pairs

- Click on KeyPairs tab
- Click on “Create a new keypair” icon
- Enter a name for the key pair (Example: “eucakey” etc.)
- Choose location on the client machine to save the ID file to (You will need this to use with putty etc. to make an SSH connection)



## Define Security Groups

- Click on SecurityGroups tab
- Enter a name for the group (Example: “Eucalyptus”, “EucaGroup” etc.)
- Enter the description and click on ”Create” button
- You will have an option to specify some basic ports like SSH/RDP to be opened up while creating the group itself. After the group is created, you can add rules any time by choosing the security group in the left pane titled “Your groups” and adding rules in the right pane titled “Group Permissions”

## 5.2 Hybridfox

[Hybridfox](#) was forked from Elasticfox to make it usable with Eucalyptus, when Elasticfox worked only with AWS. Hybridfox can be used as the single interface to AWS and Eucalyptus.

The interface of Hybridfox is similar to Elasticfox and all the above steps in configuring Elasticfox apply to Hybridfox as well.

Even after the recent release of Elasticfox (version 1.7) with support for Eucalyptus, Hybridfox has the following additional features that make it attractive for users of Eucalyptus:

- Raising instances with Private IP
- Some quirks related to hard coded mapping of instance types and architecture types addressed
- Support for Eucalyptus 1.5.x as well as 1.6.x
- Other usability enhancements

You can install the extension from <http://code.google.com/p/hybridfox/downloads/list>. The latest version (at the time of writing) is hybridfox-1.6.000030.xpi.

You will need to restart Firefox before you can start using Hybridfox. You can access Hybridfox from “Tools” menu of Firefox.

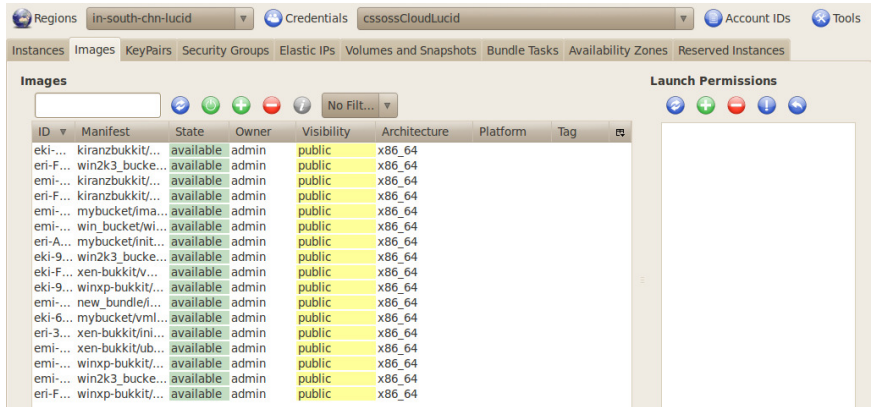


Figure 5.1: Images in HybridFox

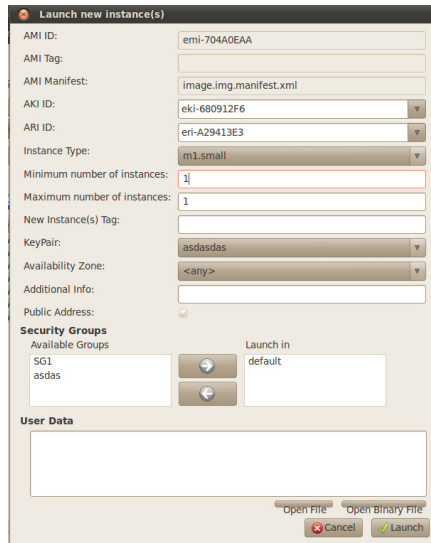


Figure 5.2: Launching an instance in HybridFox

## 5.3 Command Line Tools (Euca2ools)

Euca2ools from Eucalyptus provide a bunch of command line tools to manage the eucalyptus setup. These commands help you manage images, instances, storage, networking etc. A few commands related to managing the instances are given below.

For a complete list of commands, see Appendix.

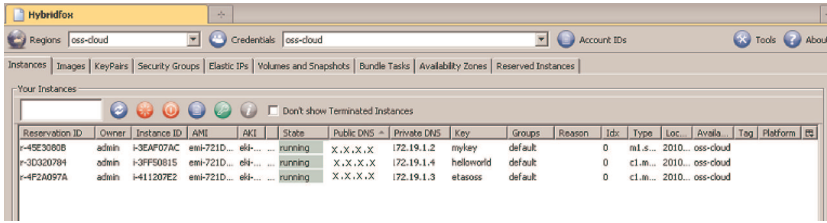


Figure 5.3: Instances in HybridFox

To install `euca2ools` execute the following command:

```
$ sudo apt-get install euca2ools
```

### 5.3.1 Creation of Key Pairs

Eucalyptus expects the client tools to use two kinds of credentials. One set of credentials are called Access Key and Secret Key that all clients need to use to make any requests to the Cloud Controller. Each user registered on the web interface has this set created for him. You can download it from the web interface as mentioned in the chapter on “Web interface”.

You will also need to generate a keypair consisting of private key/public key to be able to launch instances on Eucalyptus. These keys are injected into the instance and used to make passwordless SSH access to the instance possible.

Keypairs can also be generated using the following commands:

```
uecadmin@client1:~$ cd ~/.euca
uecadmin@client1:~/.euca$ source eucarc
uecadmin@client1:~$ euca-add-keypair mykey > mykey.priv
uecadmin@client1:~$ chmod 600 mykey.priv
```

This creates a new keypair called `mykey`. The private key `mykey.priv` is saved locally which can be used to connect to an instance launched with `mykey` as the keypair. To list the available keypairs:

```
uecadmin@client1:~$ euca-describe-keypairs
KEYPAIR mykey

To delete an existing keypair:

uecadmin@client1:~$ euca-delete-keypair helloworld

The above tasks can be achieved using Hybridfox from the “Keypairs” tab.

### 5.3.2 Launch and manage instances

The following commands can be used to launch an instance from the above generated keypair, check its status, connect to the instance etc.:

Make sure that you launch the instance with the correct VM type. If it is launched with a smaller VM type, then the following error is encountered:

```
error: insufficient disk capacity remaining
```

By default, `m1.small` is the VM type that is used which comes with 2GiB of disk space. So if you have a disk image of size 5GB, instead of

```
uecadmin@client1:~$ euca-run-instances emi-XXXXXXX -k mykey
```

use the following command to run the instance as a better suited VM type:

```
uecadmin@client1:~$ euca-run-instances emi-XXXXXXX -k mykey -t
c1.medium
```

VM type also has implications for amount of RAM and number of CPUs allocated to the instance. To know the configured VM types, please see the Configuration page of the web interface.

## 5.4 Life cycle of an instance

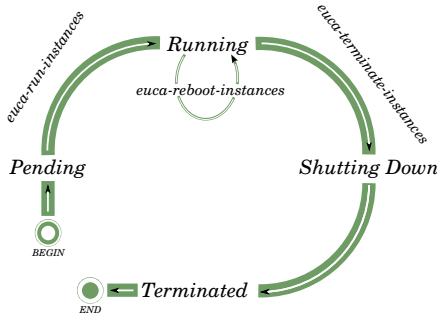


Figure 5.4: Instance Lifecycle

When you invoke “`euca-run-instances`” command (or when you choose to run an instance from Hybridfox/Elasticfox), here are a few things that happen on various components of UEC:

- Authentication/Authorization of the user request to ensure you have permission to launch the instance
- Identification of CC to take responsibility for deploying the instance and identification of the NC for running the instance.
- Downloading the image from WS3 to NC (images are cached so that starting multiple instances of the same machine image downloads that image only once)

- Creating the requested virtual network interface
- Starting the instance of the machine image running as a virtual machine using KVM

Starting and stopping of an instance is a complex process involving multiple components of UEC and a more detailed discussion is beyond the scope of a beginner's guide.

# Chapter 6

## Storage management

### 6.1 Storage Controller

Storage Controller is the component of Eucalyptus that provides persistent block storage compatible with Amazon's Elastic Block Store. `euca2ools` or `EC2` commands can be used to manage these volumes. Here are a few `euca` commands for managing the volumes

### 6.2 Interacting with Storage Controller

#### 6.2.1 Linux Instances

Create a 10 GB volume:

```
uecadmin@client1:~$ euca-create-volume -s 10 -z mycloud
VOLUME vol-333C04B8 10 creating
2010-03-26T05:20:56.383Z
```

List the volumes:

```
uecadmin@client1:~$ euca-describe-volumes
VOLUME vol-333C04B8 10 mycloud available
2010-03-26T05:20:56.383Z
```

Attach a volume to a running instance:

```
uecadmin@client1:~$ euca-attach-volume -i i-41620887 -d /dev/sdb
vol-333C04B8
```

The volumes status changes from “available” to “in-use” if it is attached properly as shown in the output of “euca-describe-volumes” below:

```
uecadmin@client1:~$ euca-describe-volumes
VOLUME vol-333C04B8 10 mycloud in-use 2010-03-26T05:41:28.019Z
ATTACHMENT vol-331F04B2 i-41620887
unknown,requested:/dev/sdb 2010-03-26T05:43:51.343Z
```

You can login to the instance through SSH and see the new volume as a newly attached block storage, which shows up in the example below as `/dev/sdb`:

```
$ sudo fdisk -l
Disk /dev/sda: 2195 MB, 2195718144 bytes
4 heads, 32 sectors/track, 33504 cylinders
Units = cylinders of 128 * 512 = 65536 bytes
Disk identifier: 0x000adc1c
   Device Boot Start End Blocks Id System

You can format `/dev/sdb`, mount it and use it as a persistent storage. It is better to unmount the volume before bringing down the instance, to avoid any data corruption.

Detach a volume:

```
uecadmin@client1:~$ euca-detach-volume vol-333C04B8
```

## 6.2.2 Windows Instances

For Windows instances, the procedure for creating the volume and attaching the volume is the same.

Note: Even while attaching to Windows instances, the device has to be specified as `/dev/sdb`.

The only change is the way this disk is accessed. Once the disk is attached to a running Windows instance, perform the following steps:

- Connect to Windows instance via RDP



- Go to Start -> Run and type diskmgmt.msc without the quotes. Select OK. This opens the Disk Management console
- Right click on the new disk at the bottom of the list and choose Initialize Disk Confirm initialization
- Right click on the volume and select “New Partition”
- Accept the defaults or modify to suit your setup and proceed with formatting
- After completion the disk management tool shows a healthy partition on the new drive.

To detach a volume from an instance use `euca-detach-volume` command:

```
uecadmin@client1:~$ euca-detach-volume vol-333C04B8
```

Note that the volume has to be unmounted before detaching it from the instance. Volume can be deleted using `euca-delete-volume` command:

```
uecadmin@client1:~$ euca-delete-volume vol-333C04B8
```

## 6.3 WS3 Storage Controller

Walrus is a storage service in Eucalyptus which is compatible with Amazon's S3. Using Walrus users can store persistent data, which is organized as buckets and objects. WS3 is a file level storage system, as compared to the block level storage system of Storage Controller.

See Amazon's S3 Getting Started Guide for more information <http://docs.amazonwebservices.com/AmazonS3/2006-03-01/gsg/>.

Walrus Controller options can be modified from the Web UI, on the “Configuration” page under “Walrus Configuration” section.

For using Walrus to manage Eucalyptus VM images, you can use Amazon's tools to store/register/delete them from Walrus. Other third party tools can also be used to interact with Walrus directly.

### 6.3.1 Third party tools for interacting with Walrus

- `s3curl` S3 Curl is a command line tool that is a wrapper around `curl`. <http://open.eucalyptus.com/wiki/s3curl>

- s3cmd is a tool that allows command line access to storage that supports the S3 API. <http://open.eucalyptus.com/wiki/s3cmd>
- s3fs is a tool that allows users to access S3 buckets as local directories. <http://open.eucalyptus.com/wiki/s3fs>

## 6.4 Snapshots

The volumes that have been created on the Block Storage can be used to create point-in-time snapshots of volumes, which are stored on WS3. These snapshots can be used as the starting point for new Block Storage volumes and protect data for long-term durability. The same snapshot can be used to create volumes when needed.

Snapshots can be created by using `euca-create-snapshot` command:

```
uecadmin@client1:~$ euca-create-snapshot vol-333C04B8
```

`euca-describe-snapshots` lists the available snapshots:

```
uecadmin@client1:~$ euca-describe-snapshots
SNAPSHOT snap-32A804A2 vol-333C04B8 completed
2010-04-15T13:48:32.01Z 100%
```

Volumes from these snapshots can be created by using the snapshot ID:

```
uecadmin@client1:~$ euca-create-volume -s 10 --snapshot snap-32A804A2
--zone mycloud
```

Please note that the volume can only be created after the snapshot status is completed. Similarly, snapshots from a volume can only be created after the volume status is created, but not during the creating stage. To delete a snapshot:

```
uecadmin@client1:~$ euca-delete-snapshot snap-32A804A2
```

# Chapter 7

## Eucalyptus Networking

### 7.1 System

In System mode, CC generates and assigns a random MAC address to the VM instance while requesting NC to bring up the instance. NC attaches the VM instance's virtual NIC to the physical NIC on the node through a bridge. This mode requires that the Nodes are connected to the enterprise network directly. Instances obtain an IP address using DHCP, just as physical machines on the network do.

This mode is very easy to setup as it does not have any additional prerequisites in terms of networking, except for a running DHCP server on enterprise network. It is a good way to get started with Eucalyptus, particularly if you want to set it up on your laptop/desktop to get a basic understanding.

This mode of networking is similar to “Bridged Networking” that hypervisors like VMware, VirtualBox etc. offer or like “tap” networking offered by KVM/Qemu.

### 7.2 Static

Static mode offers the Eucalyptus administrator more control over VM IP address assignment than System mode does. In this mode, the administrator configures Eucalyptus with a “map” of MAC address/IP address pairs on CC.

Before requesting NC to raise an instance, CC sets up a static entry within a Eucalyptus controlled DHCP server, takes the next free MAC/IP pair,

and passes on to NC, which attaches the virtual NIC of the instance to the physical NIC of the Node through a bridge similar to how it is handled in System mode.

This mode of networking is similar to “Bridged Networking” that hypervisors like VMware, VirtualBox etc. offer or like “tap” networking offered by KVM/Qemu.

This mode is useful for administrators who have a pool of MAC/IP addresses that they wish to always assign to their instances without relying on the DHCP server running in the enterprise network.

Note – Running Eucalyptus in System or Static mode disables some of the following key functionalities that would make an enterprise deployment more manageable:

- Ingress filtering for the instances (Security Groups)
- User Controlled dynamic assignment of IPs to instances (Elastic IPs)
- Isolation of network traffic between instances VMs
- Availability of the metadata service (use of the <http://169.254.169.254/> URL to obtain instance specific information)

## 7.3 Managed

Managed mode is the most feature-rich mode offered by Eucalyptus. In this mode, the Eucalyptus administrator defines a large network (usually private and unroutable) from which VM instances will draw their IP addresses. As with Static mode, CC will maintain a DHCP server with static mappings for each instance that is raised and allocate the right IPs at the time of requesting an NC to raise the instance.

Managed mode implements “security groups” for ingress filtering and isolation of instances. The user specifies a security group to which the new instance should be associated with, at the time of requesting a new instance. CC allocates a subset of the entire range of IPs to each security group in such a way that all the instances raised to be a part of the same security group use IPs from the same subset.

The user can define ingress filtering rules at the “security group” level. More on this in the chapter on Security. In addition, the administrator can specify a pool of public IP addresses that users may allocate, either while raising the instances or later at run-time. This functionality is similar to “elastic IPs” of AWS.

Eucalyptus administrators who need to implement require security groups, elastic IPs, and VM network isolation must use this mode.

## 7.4 Managed NOVLAN

This mode is identical to MANAGED mode in terms of features (dynamic IPs and security groups), but does not provide VM network isolation. Eucalyptus administrators who want dynamic assignable IPs and the security groups, but are not in a position to run on a network that allows VLAN tagged packets or those who do not have a need for VM network isolation can use this mode.

## 7.5 Comparison of Eucalyptus Networking Modes

## 7.6 Configurations

For the sake of convenience, the following network setup is assumed.

Managed and Managed-NOVLAN:

- CC – two interfaces eth0 and eth1. eth1 is connected to internet and eth0 is connected to NC.
- NC – one interface eth0, which is part of bridge br0 and this is connected to CC.

System and Static Mode

- CC – one interfaces eth0 connected to the enterprise network.
- NC – One interface eth0, which is part of bridge br0 connected to the enterprise network.

The following settings have to be made in `/etc/eucalyptus/eucalyptus.conf` file on CC and NC to configure the corresponding networking mode.

# Chapter 8

## Security

Eucalyptus provides ingress filtering for the instances based on the concept of security groups. A Security Group is a named set of rules that Eucalyptus applies to the incoming packets for the instances in Managed and Managed-NOVLAN modes. You can specify a security group while launching an instance. Each security group can have multiple rules associated with it. Each rule specifies the source IP/network, protocol type, destination ports etc. Any packet matching these parameters specified in a rule is allowed in. Rest of the packets are blocked.

A security group that does not have any rules associated with it causes blocking of all incoming traffic.

The mechanism only provides ingress filtering and does not provide any egress filtering. As a result all outbound traffic is allowed. If you need to implement egress filtering, you will need to implement that inside the instance using a firewall.

Tools like Hybridfox let you manage security groups and also let you specify a security group while launching an instance.

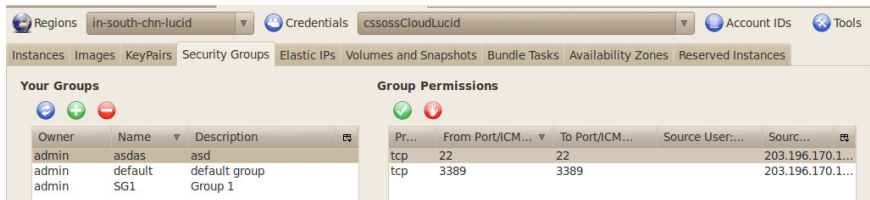


Figure 8.1: Security Groups in HybridFox

Here are a few euca commands to manage security groups:



Create a security group named “webservers”:

```
uecadmin@client1:~$ euca-add-group -d "Web Servers" webservers
```

Add a rule to the security group “webservers” allowing icmp and tcp traffic from a.b.c.d:

```
uecadmin@client1:~$ euca-authorize -P tcp -s a.b.c.d webservers
uecadmin@client1:~$ euca-authorize -P icmp -s a.b.c.d webservers
```

The added rules can be viewed with euca-describe-groups command:

```
uecadmin@client1:~$ euca-describe-groups
GROUP admin default default group
GROUP admin webservers Web Servers
PERMISSION admin webservers ALLOWS icmp -1 -1 FROMCIDR 0.0.0.0/0
PERMISSION admin webservers ALLOWS tcp 22 22 FROMCIDR 0.0.0.0/0
```

Launch an instance associated with the security group “webservers”:

```
uecadmin@client1:~$ euca-run-instances emi-XXXXXXX -k mykey -g
webservers
```

List the details of the existing security groups:

```
uecadmin@client1:~$ euca-describe-groups
```

Remove the rule for icmp traffic from the source ip a.b.c.d from the security group “webservers”:

```
uecadmin@client1:~$ euca-revoke -P icmp -s a.b.c.d webservers
```

Delete the security group “webservers”:

```
uecadmin@client1:~$ euca-delete-group webservers
```

# Chapter 9

## Troubleshooting

### 9.1 Eucalyptus Log Files

The following log files help in debugging issues encountered while working with Eucalyptus:

Eucalyptus Component	Log File
CC	cc.log, httpd-cc_error_log, cc-registration.log
NC	nc.log, httpd-nc_error_log, euca_test_nc.log
CLC	cloud-debug.log, cloud-error.log, cloud-output.log, axis2c.log
SC	sc-stats.log, sc-registration.log
WS3	walrus-stats.log, walrus-registration.log

Table 9.1: Component Log Files

The logging level is controlled by the LOGLEVEL macro in eucalyptus.conf of the respective component. The log levels are DEBUG, INFO, WARN, ERROR, and FATAL (in descending order of verbosity). The default level is DEBUG (everything).

“tail -f ” on the log files is a good way to understand what is happening with the components of Eucalyptus.

### 9.2 Linux commands

Linux comamnds like ps, top etc. run on CC and NC are helpful to understand the state of the processes related to Eucalyptus.

## 9.3 Libvirt tools

NC launches the instances by making libvirt calls to launch a VM. You can use libvirt tools like virsh for troubleshooting any hypervisor related issues.

## 9.4 Launching an instance with VNC attached (Hack)

If the output of `euca-describe-instances` shows the status of an instance as “running”, but if you are not able to SSH into it or RDP into it, it is tough to find out where the failure is. In such cases, a VNC interface to the instance is generally of great help to troubleshoot further. But Eucalyptus does not provide a way of connecting to the instance through VNC. The following hack can help in setting up a VNC interface to the instance.

### 9.4.1 Windows instances

On the NC, edit `/usr/share/eucalyptus/gen.kvm.libvirt.xml` (if KVM is the hypervisor) to change

```
<devices>
  <disk type='file'>
    <source file='BASEPATH/disk'/>
    <target dev='sda'/>
  </disk>
  <interface type='bridge'>
    <source bridge='BRIDGEDEV'/>

to:

```
<devices>
  <disk type='file'>

    <mac address='PRIVMACADDR'/>
    <model type='e1000'/>
  </interface>

```

</devices>

where A.B.C.D is the IP address of the interface on NC that is reachable from the client machine where you want to run the VNC client. We assume that your NC has two interfaces and you are able to use the second interface to reach it without going through CC. Again, this is only for troubleshooting. In a production setup, you may have the NC connected to the outside world only through CC.

With these changes, KVM adds the “-vnc” option to the command with the specified NC’s IP address on display number 4.

To connect to the instance through VNC client from a different machine, use the NC’s IP address and display number 4.

Ex: A.B.C.D :4

In the case of Xen, you would modify the relevant sections of `/usr/share/eucalyptus/gen.libvirt.xml`. We have not tested with Xen, though.

## 9.4.2 Linux instances

You can use the same approach for Linux instances as well, with the caveat that you will not see any output with `euca-get-console-output` as console output does not get written to `/var/lib/eucalyptus/instances/<user>/i-xxxxxxx/console.log`. The output will, of course, be displayed though VNC.

Note: This works only if we are debugging one instance at a time. If you attempt to start another instance while one instance is already running, KVM will try to attach the same VNC display 4 to the second instance and will fail with the following error in `/var/log/libvirt/qemu/i-XXXXXXXXX.log`:

```
inet_listen_opts: bind(ipv4,A.B.C.D,5904): Address already in use
inet_listen_opts:FAILED
```

## Hacks

### B.1 Bringing up a Windows instance without using kernel and ramdisk images

Edit `/usr/share/eucalyptus/gen_kvm.libvirt.xml` to remove the lines that add “-kernel” and “-initrd” options in the libvirt.xml.

Here is the patch for `/usr/share/eucalyptus/gen_kvm.libvirt.xml` that ships with Ubuntu 10.04 (Lucid Lynx):

DISCLAIMER: This patch works with the Windows instances on Lucid Lynx. This would work as long as all your disk images are bootable and you don't need the kernel and ramdisk images. If you need the flexibility of launching instances using different kernel/ramdisk combinations, this hack is not for you!
